



Thank you for your purchase of Marine Decking. This Limited Warranty is made by Marine Decking. This Warranty establishes the whole agreement between Marine Decking and the Buyer as to any warranty given by Marine Decking to the Buyer for our product.

We warrant that our product will be free from defects in our materials at time of manufacture and workmanship of material from polymer degrading, excessive fading as a result from defective materials

We give a 3-year limited warranty starting from time of purchase or from when our product is dispatched from our warehouse. Defected products is limited to repair or replacement as follows below in this Limited Warranty description.

Buy Purchasing Marine Decking products the Buyer understands and accepts and agrees our warranty policy and our terms and conditions.

The buyer has had ample time and opportunity to consult with legal advice in regard to our limited warranty and understands our warranty.

## WHO THIS WARRANTY APPLIES TO

Marine Decking Located at UNIT 40a 1-3 Endeavour Road, Caringbah NSW 2229 Phone 0468 458 884 extend this limited warranty only to the buyer (consumer) who originally purchased the product. We do not extend to any following owner or transferee of the product. This limited warranty cannot be transferred to any other person or entity.

## WHAT THIS LIMITED WARRANTY COVERS

This limited warranty covers our products from defects in our material's and workmanship at the time of manufacture. This covers the product for 3 years from the date of purchase or when the product is shipped from Marine Decking warehouse defined in the invoice or receipt. The limited warranty period is not extended if we repair or replace the product or material. We may change the availability of this limited warranty at any time, any changes will not be retracted.

## WHAT THIS LIMITED WARRANTY DOES NOT COVER

This Limited warranty does not cover (1) adhesion of the product to Fiber-glass, aluminium or any other surface which the product is adhered to; (2) installation of product to any surface; (3) some

fading/discolouring, expansion, shrinking or polymer degradation of the product resulting from non-defective product from time of manufacture; (4) accidental causes or normal wear and tear; (5) unauthorized repair or modifications to the product ; (6) failure to perform preventative maintenance or not following product instructions ; (7) damage to covered surface or structure; (8) damage to material or product from exceeding temperatures above 73C (MAX TEMP) which can be caused from sunlight or heat amplification from reflected surfaces through mediums like glass plastic or structures which refract or trap sunlight and heat; (9) Installations resulting in the product being subject to temperatures above MAX TEMP will void warranty.

## HOW CAN YOU OBTAIN WARRANTY

To obtain warranty during the warranty period you must fill out our warranty claim form or email us at [info@marinedecking.com.au](mailto:info@marinedecking.com.au) or call 0468 458 884. During this process you may be asked to provide proof of purchase, photos, evidence of defective products or materials so it can be evaluated by Marine Decking. You may also have to send defective products or materials back to Marine Decking warehouse located at Unit 40a 1-3 Endeavour Road, Caringbah NSW 2229. Shipping costs will not be covered by Marine Decking to and from warehouse, it is up to the owner or buyer of product to cover all shipping costs. If deemed defective by Marine Decking we will repair, replace or refund the cost of only the defective product or material in accordance to our terms of this limited warranty.

## LIMITATIONS OF MARINE DECKING LIABILITY

Marine decking total liability will not exceed the value of the actual product sold to the buyer. Marine decking under no circumstances will not be liable for any direct or indirect damages or losses of any type.
